If the transition for the HCR doesn't get done in time we can still use Thorsby HCR. There are 4 associations around Winfield and Hockey AB is expecting that each of the 4 will take some of their boundary area. Chad will start on the boundary areas not involved with Winfield and then we can go from there.

Junior C

Around end of season Cory was asked about a Junior C Team, Chris Holt would coach. Around 20 kids interested. Cory has emailed the president of the Noralta League, but hasn't heard back yet, he is waiting to see about deadlines. If the timeline is feasible, then need to sit down with the ones who want to be involved to make sure there is enough interest that this would be a long-term commitment, and not just a 2-3 year thing. Would have to make sure that this isn't taking away from our home teams. No concern for ice time with the 3 rinks. Would be in favour if this is a feasible venture. Would be under Hockey AB Insurance within our league. It looks like there is a lot involved and might need to add a Junior C director if this happens.

Signing Authority / Bank Account

Cory makes motion, to open a new Bank Account, with President, Treasurer and Secretary to have signing Authority, Dewey seconds this.

Sherri makes a motion that, if possible, to transfer the team accounts from Thorsby Minor Hockey to West 39 Minor Hockey, once the new account opens, Dewey seconds this.
